- Q: Have you talked to anyone else about your concerns about May being the date that she was talking about cutting someone?
- A: Yeah.
- Q: Who else?
- A: Um, probably, uh, probably, I think Steve. And I think, uh, my friend, Randy, Randy Herson (phonetic) and, uh, you know, I told my, I've expressed that, I mean that's what I told, um, let me see - - -
- Q: When you say Steve, what Steve are you referring to?
- A: Steve, whatever, Psychow, Psychowski, whatever his name is.
- Q: You're talking the same Steve you were referring to earlier that Blaze stayed with?
- A: Yeah. Yeah.
- Q: Is that the one that's with Cathy?
- A: Correct.
- Q: Did you speak with Cathy?
